

Lb Cakes | Terms and Conditions

1. An initial deposit of \$50 reserves your event date and is non-refundable.
2. A deposit of 50% is required to be paid 1 month before the delivery date. The remaining balance is due one week before the delivery date. If the order is canceled, 50% of the total cost of the cake is non-refundable.
3. The date of your final payment is the final date for any changes of size, style or flavors of the cake. Any changes requested after this date cannot be guaranteed and may be subject to additional charges.
4. The colors blue, purple, red and black or any shade of these colors cannot and will not be guaranteed. These colors are very unstable and tend to fade and or bleed into surrounding colors of frosting.
5. Lb Cakes is not responsible for any damage to the cake after setup is complete. You are responsible for providing or renting a sturdy and appropriately sized cake stand (at least the width of the cake base), secure table and environment for the cake/cupcakes. The optimal room or outdoor temperature is 72 degrees or below. Any temperature above this may result in softening or melting frosting and shifting of the cake.
6. If flower arrangement instruction is given to Lb Cakes in advance or silk flowers are used, I will arrange one bundle for \$10, two for \$20, etc. It is the responsibility of the florist to determine flower safety and safe food practice and not Lb Cakes. You acknowledge that fresh flowers are not a food product, and may contain pesticides, insects, dirt, or other contaminants.
 - a. Discussion with the florist should occur prior to the wedding to ensure flowers will be wired together by florist. If Lb Cakes finds, upon arrival at the venue, that flowers are not wired together, the additional floral charge will be \$20 per bundle and be required to be paid within 1 week of event.
 - b. Lb Cakes' is not responsible for any non-edible items (silk flowers, pearls, ribbons, cake toppers, etc.) placed on your cake. It is your responsibility to remove these items before the cake is consumed.
7. If you choose to waive the \$50 set-up/delivery fee and have someone else pick up and set up the cake, you assume all liability and responsibility for the condition of the cake once it leaves Lb Cakes' possession (ie. Keeping the cake stable during transportation, keeping the cake and cupcakes cool until serving, etc.).
8. Lb Cakes' products may contain or come into contact with milk, wheat, nuts, soy and other allergens. You agree to notify your guests of this risk and not hold us accountable for allergic reactions.
9. Performance of this agreement is contingent upon the ability of Lb Cakes to complete the agreement and is subject to unavoidable situations, such as a car accident or poor road conditions during delivery. Lb Cakes will not be held liable for more than the cost of the above ordered cake(s) and/or cupcake(s).
